**ORDER UNDER SECTION 144 Cr.P.C.**

**No.EGH/CON.231/2020/Pt-VII/142:** Whereas in pursuance of Order issued by Home(Political) department vide No. POL.75/2020/Pt-I/91, dated 28<sup>th</sup> April, 2021 and in continuation of the order issued by undersigned vide No.EGH/CON.231/2020/Pt-VII/108, dated 30 April 2021, And whereas, in view of the prevailing situation concerning COVID – 19 in the country, state and globally. And whereas, to put in place preventive measures to contain the pandemic of COVID – 19 by way of observance of strict protocols of and advisories issued by Government of Meghalaya, Health & Family Welfare Department.

Now, therefore, I, **Swapnil Tembe, IAS, District Magistrate, East Garo Hills District, Williamnagar** in exercise of the powers conferred upon me under section 144 Cr.P.C read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby impose following **CONTAINMENT MEASURES:-**


1. All schools, colleges, coaching institutions and other educational institutions to remain closed in the entire district of East Garo Hills till 20<sup>th</sup> May, 2021. They are encouraged to continue online classes to the extent possible.
2. Night Curfew from 10:00 P.M to 5:00 A.M all over the District will continue until withdrawn. However, it will not be applicable to Security forces, Medical team and other Emergency Services including goods transport and Inter State transport.
3. All shops and commercials establishments shall close everyday at 7:00 PM all across the district.
4. Weekend Lockdown will be imposed from 10 AM of 14<sup>th</sup> May 2021 till 5 AM of 17<sup>th</sup> May 2021.
5. Operation of weekly markets will be restricted to only agricultural items, vegetables and fruits.
6. Places of religious worship shall remain closed except for wedding ceremony with prior permission of the undersigned.
7. Political, Public, Social and religious gatherings are not permitted including conferences, meetings and trainings. Weddings and Funerals are, however, permitted subject to a ceiling of 30 persons and with prior permission of the Deputy Commissioner.
8. Entry of tourists from outside the State shall not be permitted and all tourist spots shall remain closed.
9. Sports activities are not permitted.

**Wearing of face Mask/Covering of mouth and nose when coming out mandatory and spitting & smoking in the public places is prohibited. Violators will be imposed penalty by the designated Officers.**

In view of the urgency of the matter, this order is being passed ex parte and it shall come into force with effect from 10<sup>th</sup> May, 2021 until further order.


